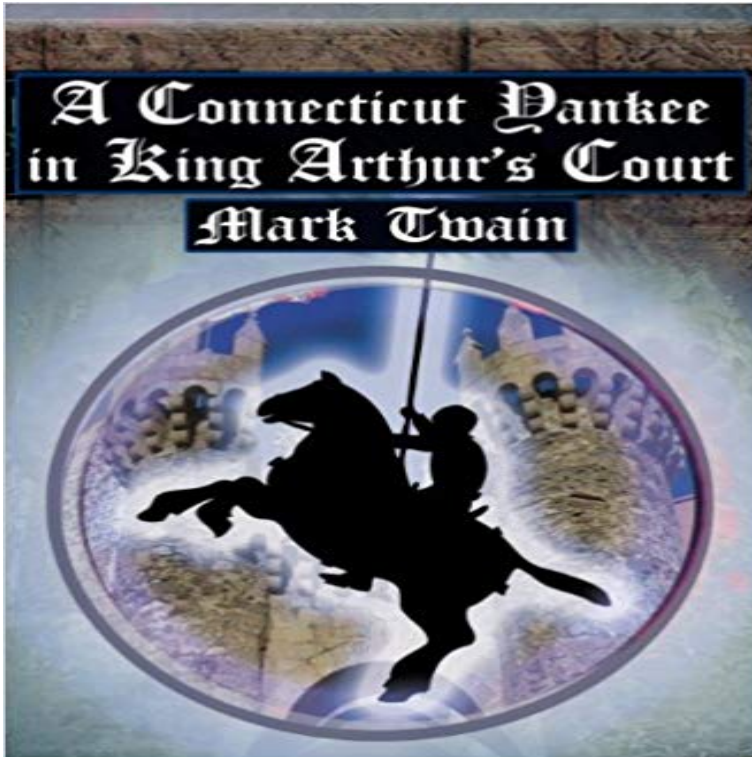


A Connecticut Yankee in King Arthurs Court: Twains Classic Time Travel Tale
