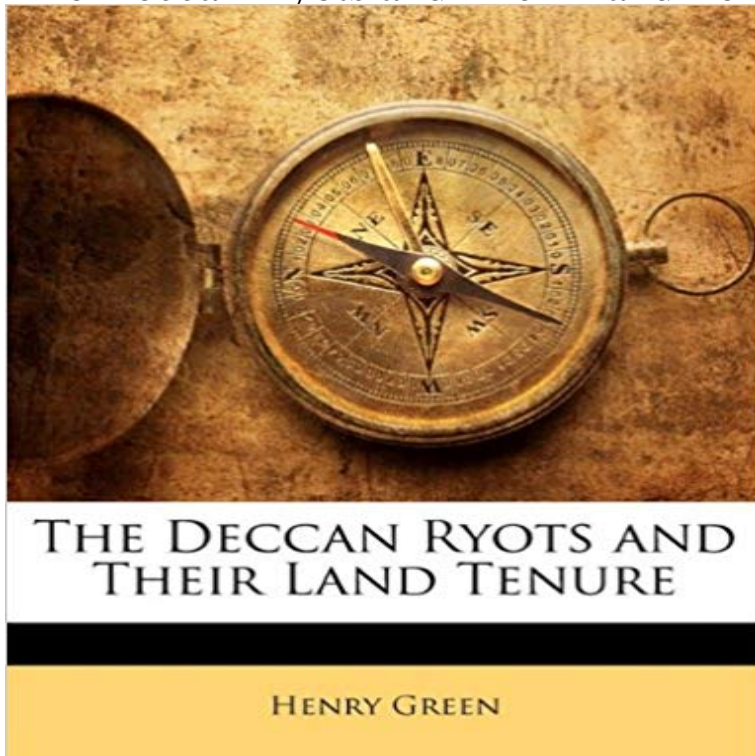


The Deccan Ryots and Their Land Tenure
